







## **Chemical Focus is Critical**

- > 10,000 + chemicals in commerce at any time
  Fewer than 700 chemicals are regulated
- 2,800 high-production-volume chemicalsComplete hazard data available on 7%
- > Implications
  - Overwhelming need for more chemical information
  - Sheds doubt on the presumption of safety
  - Regulations are necessary, but limited to clear risks
  - Organizations must become responsible for smart chemical substitution
